It is my complaint that Rita Hayes is in violation of election laws, as she is being paid by the Derrick Wallace campaign to collect and deliver absentee ballots for the campaign. She has been seen with a stack of absentee ballots, which is in violation of the 2 per election law.

On August 1, 2014, Rita Hayes approached Cynthia Harris in an attempt to collect an absentee ballot. When Ms. Harris informed Ms. Hayes that she was breaking the law, Hayes disregarded Ms. Harris and proceeded to tell her that she was only there to assist. At that point, Ms. Harris began to gather evidence by taking pictures (see attachment) because it was apparent the Derrick Wallace campaign worker would continue her efforts in breaking election laws. August 4, 2014, Rita Hayes returned to once again collect on an absentee ballot. This time she had another woman with her (Sandra Lewis) both were wearing Derrick Wallace campaign t-shirts (see attached). In addition to Rita Hayes attempting to collect absentee ballots from the same person twice, the attached photo shows Rita Hayes holding a clipboard with a stack of absentee ballots. Attachments are photos, eyewitness statements, campaign finance reports and a grievance letter requesting an investigation and official challenge of all absentee ballots allegedly cast for Derrick Wallace.

RE: Election Fraud Complaint

Division of Elections:

This letter serves as my official grievance concerning election fraud activities in Orange County, Florida. As stated in my complaint against RITA HAYES, I have provided photos, eyewitness accounts and campaign finance report which indicates Ms. Hayes (paid Derrick Wallace campaign worker) as being in violation of the State of Florida election laws. Subsequently, I hereby challenge every absentee ballot cast for Derrick Wallace, as the validity of these ballots are in question and the uncertainty that ballots not cast for Wallace ever made it to the Supervisor of Elections. I request a full investigation into this matter.

Upon the State's investigation and finding violations of election laws, I request the following actions:

- (1) To order Rita Hayes and the Derrick Wallace campaign to cease and desist from committing further violations;
- (2) To nullify all absentee ballots allegedly cast for Derrick Wallace, as so challenged in the complaint
- (3) To pay a civil penalty not to exceed \$5,000.00 for each violation to complainants attorney fees;
- (4) To publicly reprimand any violator found to have committed a violation;
- (5) To require that restitution be paid by any violator to a state, county, or city governing authority when it has suffered a monetary loss or damage as the result of the violation;
- (6) To prosecute the violators to the full extent of the law.

The 2014 Florida Statutes

Title IX

CHAPTER 104

ELECTION CODE: VIOLATIONS; PENALTIES

104.0616 Absentee ballots and voting; violations.—

(1) For purposes of this section, the term “immediate family” means a person’s spouse or the parent, child, grandparent, or sibling of the person or the person’s spouse.

(2) Any person who provides or offers to provide, and any person who accepts, a pecuniary or other benefit in exchange for distributing, ordering, requesting, collecting, delivering, or otherwise physically possessing more than two absentee ballots per election in addition to his or her own ballot or a ballot belonging to an immediate family member, except as provided in ss. 101.6105-101.694, commits a misdemeanor of the first degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.
