- 3. RE GRADE ENTIRE SITE TO SURROUNDING GRADES, RE GRADE ENTIRE AREA AND LEAVE SITE FREE OF DEMOLITION DEBRIS AND SPOILS.
- 4. COMPLETELY REMOVE AND DISPOSE OF THE EXISTING GREEN WALL& SOIL HOLDING AREA IN THE OUT FIELD. REMOVE ASPHALT PAVEMENT ON THE SOUTH AND NORTH LAYDOWN AREA. **THE LIMEROCK BASE COURSE TO REMAIN**. REMOVE ALL TREES BETWEEN OUTFIELD AND TRAILERS, ALSO ALONG TAMPA AVE. RIGHT OF WAY, INCLUDING ENTIRE TREE, ROOTS, STUMPS, AND TREE DEBRIS.
- 5. LEAVE ALL HISTORIC INFIELD CLAY, GRUBB OUT ALL GRASSES AND VEGETATION ON ENTIRE SITE. IMPORT CLEAN FILL GRADE PROPERLY FOR ACTIVE DRAINAGE AND COMPACT.
- 6. HAUL ALL DEMOLITION DEBRIS OFF SITE TO AN APPROVED LANDFILL OR RECYCLING CENTER FOR PROPER DOCUMENTED DISPOSAL.
